## Named Endowed Gifts

Endowed gifts will recognize your generosity in perpetuity. You may make your gift over one to five years or in combination with your estate.

### **\$2,000,000 - Mass Eye and Ear Chair**

Chairs are named endowments that exist in perpetuity. They provide enduring financial support for clinicians and scientists to pursue new solutions to tough medical problems through pioneering research and training the next generation of leaders and experts in their specialties.

### **\$1,000,000 - Named Endowed Fellowship**

Naming an endowed fellowship enables you to support the education and training of the next generation of specialists. You may designate your fellowship to a specific division.

### **\$500,000 – Young Investigator Award**

Young Investigator Awards provide dedicated support to early-career researchers to further their field of study. You may name the award after yourself or a loved one, as well as designate a preferred specialty.
